**A RESOLUTION AUTHORIZING THE AUDITOR TO TRANSFER FUNDS AND  
INCREASE APPROPRIATIONS**

**WHEREAS**, in cooperation with the Ohio Department of Transportation, the City of London has agreed to a project to resurface portions of US 42 (from London South Corporation Limit along High and Elm Streets, to Lafayette St.) and SR 38 (from Lafayette St. to SR 29), lying within the City; and

**WHEREAS**, at the time, the City of London agreed to assume and bear 100% of the entire cost of the improvement, within City limits, less the amount of Federal-aid and State funds set aside by the Director of Transportation of the State of Ohio and the financing of this project; and

**WHEREAS**, the original bid was too low; and

**WHEREAS**, the City needs to transfer and appropriate an additional \$10,170.00; and

**WHEREAS**, the Finance Committee has met and recommends the funds be transferred and appropriated.
