**A RESOLUTION AUTHORIZING THE SAFETY SERVICE DIRECTOR TO  
ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT TO SELL  
PROPERTY UNNEEDED, OBSOLETE OR UNFIT FOR MUNICIPAL  
PURPOSES**

**WHEREAS**, the City has a fire apparatus that is unneeded, obsolete or unfit for municipal purposes; and

**WHEREAS**, Ohio Revised Code § 721.15 sets forth the procedures to be followed when selling such property; and

**WHEREAS**, such statute requires the enactment of a resolution permitting the fire apparatus to be sold, whether after advertisement and bids to purchase or as a credit towards the purchase of a fire apparatus.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY  
OF LONDON, STATE OF OHIO**

**SECTION I:**

The Safety Service Director (“SSD”) is hereby authorized to advertise for bids, pursuant to R.C. § 721.15(A), for the sale of a fire apparatus, to wit: VIN 1S9A3KFD3N1003999.

**SECTION II:**

The SSD is also authorized to advertise for bids, pursuant to R.C. § 721.15(B), for bids for credit against the purchase of a pre-owned fire apparatus, as authorized by Resolution XXX-16.

**SECTION III:**

The SSD is hereby authorized to enter into a contract with the highest and best bidder based on the bids received in response to the advertisements authorized in Sections I and II above.

**SECTION III:**

That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.
